

## GTRC Scheme Rules – Update

For those who are technically minded.....

The revised Scheme Rules (version 3.2/ July 2020) and Gas Compliance Mark Style Guide (July 2020) have now been published.

The documents are attached and are available for download from the GTRC website at <http://www.gtrc.gov.au/publications/>

The main changes include:

- A number of minor formatting changes introduced through the trademark registration process.
- The Style Guide has been updated to remove a label version that is not accepted under NZ regulations.
- The Style guide includes version information and is available on the GTRC website.
- Clarification that the supplier declaration is linked to a specific certification

There was a version of both documents published in June that contained some unfortunate errors. The GTRC has received further feedback on the Scheme Rules indicating that the inclusion of 4 examples of the GCM on page 9 of the rules is potentially confusing when compared to the options available in the style guide.

Note that there is no change to requirements proposed and the intent of the new draft is to enhance clarity.
